OF THE QUTEKCAK NATIVE TRIBE**

**"A RESOLUTION TO AUTHORIZE THE SUBMISSION OF THE ALASKA STATE COUNCIL ON THE ARTS APPLICATION FOR THE DEVELOPMENT OF A 'QUTEKCAK NATIVE TRIBE (QNT) CREATIVE DEVELOPMENT OPPORTUNITY PROJECT' IN THE QNT SERVICE AREA"**

**WHEREAS**, the Qutekcak Native Tribe is the recognized tribal government operating as a 501(3)(c) non-profit in Seward, Alaska and provides services to Alaska Natives/American Indians within our tribal jurisdiction; and

**WHEREAS**, Qutekcak Native Tribe council has determined the need for quality educational and cultural development opportunities are a priority for our community; and

**WHEREAS**, the Qutekcak Native Tribe Comprehensive Plan lists improving cultural knowledge and opportunities as a priority; and

**WHEREAS**, the Qutekcak Native Tribe maintains the preservation of our native values includes enriching our tribal member's quality of life by providing access to opportunities with both personal and social interactions; and

**WHEREAS**, it is imperative that all tribal members have the opportunity to access other community services that can provide for the quality of life they desire; and

**WHEREAS**, the Qutekcak Native Tribe has grown and changed over the years and there has been no definitive programs to assist our tribal members seek opportunities to develop inherent creative skills due to the lack of qualified instruction; and

**WHEREAS**, without an appropriate means to meet the needs of interested members of our community and their needs, the children, our future, true self-determination cannot be achieved; and

**WHEREAS**, Qutekcak Native Tribe is charged with the development and implementation of programs designed to improve the quality of life within this community on behalf of our membership; and

**WHEREAS**, the Qutekcak Native Tribe, in cooperation with this community, has a successful history in coordinating the planning, implementation and management of programs for the health and social well-being of our tribal members; and

**WHEREAS**, the grant application known as the "Qutekcak Native Tribe Creative Development Opportunity Project" through the Alaska State Council on the Arts program is intended to provide the means to accomplish all as stated within this resolution.

**NOW THEREFORE BE IT RESOLVED** that the Qutekcak Native Tribe Council authorizes the “Qutekcak Native Tribe Creative Development Opportunity Project” application in support of local area community members.
