OF THE QUTEKCAK NATIVE TRIBE**

**"A RESOLUTION TO AUTHORIZE THE SUBMISSION OF THE ADMINISTRATION FOR NATIVE AMERICANS APPLICATION FOR THE DEVELOPMENT OF A QUTEKCAK NATIVE TRIBE (QNT) CHILD CARE PROGRAM FOR ALL CHILDREN IN THE QNT SERVICE AREA"**

**WHEREAS**, the Qutekcak Native Tribe is the recognized tribal government operating as a 501(3)(c) non-profit corporation in Seward, Alaska.

**WHEREAS**, Qutekcak Native Tribe council has determined the need for quality safe child care is a priority for our community; and

**WHEREAS**, the Qutekcak Native Tribe Comprehensive Plan lists improving child care services as a priority; and

**WHEREAS**, the Qutekcak Native Tribe maintains the preservation of our native values includes enriching our children's quality of life by providing access to needed assistance with both personal and social interactions; and

**WHEREAS**, it is imperative that the parents of our children have help in accessing other community services that can provide for the quality of life they need at this stage of their lives; and

**WHEREAS**, the Qutekcak Native Tribe has grown over the years and there is an identified need for programs to assist our tribal members to seek employment opportunities and with qualified day care for their children they can achieve this goal; and

**WHEREAS**, without an appropriate means to meet the needs of not only the working families in our community and the needs of the children, our future, true self-determination cannot be achieved; and

**WHEREAS**, Qutekcak Native Tribe is charged with the development and implementation of programs designed to improve the quality of life within this community on behalf of our membership; and

**WHEREAS**, the Qutekcak Native Tribe, in cooperation with this community, has a successful history in coordinating the planning, implementation and management of programs for the health and social well-being of our tribal members; and

**WHEREAS**, Qutekcak Native Tribe recognizes this program as an opportunity to take a leadership role in this community through this project; and


**WHEREAS**, the grant application known as the "Qutekcak Native Tribe Child Care Development Project" through the ANA Social and Economic Development Strategies – SEDS program is intended to provide the means to accomplish all as stated within this resolution; and

**WHEREAS**, the Qutekcak Native Tribe and Project Partners hereby commit the minimum 20% non-federal share of the project cost as required the Administration for Native Americans for the success of this project.

**NOW THEREFORE BE IT RESOLVED** that the Qutekcak Native Tribe Council authorizes the “Qutekcak Native Tribe Child Care Development Project” application in support of local area Children and their families.
